# Wingspan Group, Inc. Privacy Notice

Effective Date: December 1, 2023

Wingspan Group, Inc. ("Wingspan") understands the importance of your privacy. This Privacy Notice applies when you visit our website at wingspanscouting.com (the "website"), interact with us, or use any and all of our products and services (collectively, our "services"). Our Privacy Notice describes our collection of information during your interactions with our services, and the rights and choices you have regarding your information.

By using our services, you agree with the terms of this Privacy Notice, the Subscription Terms and Conditions and our Terms of Use.

#### **Information Collection**

Wingspan collects data, including personal information about you. "Personal information" means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household.

We collect data and personal information from a variety of different sources, including:

- Website visitors. We collect browsing information automatically from those who visit our
  website. We collect contact information, commercial information, and social media data from
  those who provide it voluntarily via contact forms, job applications, email messages, and
  social media links.
- Customers, vendors, and service providers. We will collect commercial information, contact
  information, and financial information when you voluntarily become our customer, vendor,
  or service provider.
- Cookies and trackers. We use cookies and other embedded tracking technology like web
  beacons which automatically collect users' browsing information when they use our website.
  You will find other parties' trackers on our website. Other parties like our analytics and
  advertising partners place code with cookies or web beacons embedded in them. These are
  called third-party cookies. Some third-party cookies are used to track a particular user's
  activity across the Internet.

**Sensitive Information.** Wingspan does not collect, use, or processes certain personal information classified as sensitive information under U.S. state or foreign legislation.

**Personal information retention.** Wingspan uses several criteria to determine how long we should keep categories of personal information. We will retain your personal information for the time period reasonably necessary to achieve the business purposes outlined in this Privacy Notice to the extent permitted by applicable law.

Please understand that residual copies of the personal information can be stored in locations or formats that make complete erasure extremely difficult. The best way to ensure you control your information is to give us only the personal information that you are completely comfortable sharing with us.

**How we use collected information.** Wingspan uses data and personal information for a variety of business purposes, as described below. We use the information we obtain about you to:

- Manage our business. Wingspan uses data and personal information to maintain user accounts, facilitate usage of the services, and complete necessary tasks to manage our business and provide our services.
- **For employment purposes.** Wingspan uses data and personal information to process and review job applications.
- **Customer purchases.** Wingspan uses data and personal information to provide customers with information about products, services, or other requested material, and to process, validate, and deliver purchases.
- Conduct research and improve our business. Wingspan uses data and personal information to conduct marketing research, such as questionnaires and surveys, and to analyze and enhance our marketing communications and strategies.
- Offers and Services. Wingspan uses data and personal information to alert you to special offers, updated information, and other new products or services from Wingspan. Wingspan also uses personal information to manage your participation in our events and other promotions, where you have signed up for such events and promotions.
- Communications. Wingspan uses data and personal information to communicate important business information, including delivering notices to you about the use of our services.
- Protect our business. Wingspan uses data and personal information to protect against fraud, unauthorized transactions, and other liabilities, and secure our services. by identifying potential hackers and unauthorized users.
- Other reasons. We may use data and personal information for other purposes with your
  consent or where permitted by law, for example to comply with applicable legal
  requirements, court orders, legal proceedings, document requests, industry standards,
  and our internal policies.

**Selling and Sharing.** In the past twelve months, Clue Perfumery has not disclosed information obtained from consumers to certain third parties in exchange for monetary or other consideration or for purposes of cross-contextual advertising. However, our use of cookies and other website tracking technologies may be considered a sale or sharing of Personal Information under certain Data Protection Laws, in which case the categories of Personal Information that we have sold or shared include identifiers (e.g., IP addresses) and internet or other similar network activity. Categories of third parties to whom Personal Information is sold or shared include data analytics providers and advertising and marketing providers. For the avoidance of doubt, we have not sold Personal Information of children under the age of 16.

 When you consent. Out of respect for your privacy, Wingspan will not disclose your data and personal information to others without your consent, except as specified in this Privacy Notice.

- With our service providers and vendors. We transfer all or a portion of your data and
  personal information to our service providers who help us deliver our products and services
  to you and for the purposes described in this Privacy Notice. These service providers are
  required by contract or law to only use or disclose the information as necessary to perform
  services on our behalf or as otherwise required by law. Although Wingspan requires these
  third parties meet our privacy and security requirements, Wingspan does not control the
  privacy or security policies of such third parties.
- With our affiliated companies. We transfer the data and personal information that we collect to other Wingspan companies, subsidiaries, and related affiliates acting on our behalf for the purposes described in this Privacy Notice.
- For a merger, acquisition, change in ownership, or reorganization. Data and personal information we have collected may be disclosed to a third party in the event of a merger, transfer of ownership or assets, bankruptcy, or other corporate reorganization.
- **For data analytics**. We share your data and personal information with analytics service providers such as Google. Google may combine your browsing information, including information from your use of our website, to generate interest-based advertisements.
- When we are legally permitted or required to do so. Wingspan may disclose without your prior consent any data or personal information about you or your use of our services, if we believe disclosure is necessary.

# **Your Privacy Rights**
